

Research & Policy


Publica's grounding in research informs all our projects. We do this to address clear gaps in the way cities are designed and built. We want to develop the ideas and policies that will make real change in successfully integrating new development; the future of the high street; safety for women, girls and gender diverse people; social inclusion; child-friendly cities; creative economies; heritage asset conservation; and housing renewal.

Our community infrastructure studies (including needs assessments) provides local authorities with a comprehensive understanding of their community assets. Our studies map distribution and quantum of facilities in relation to existing and projected populations, giving the insight needed to refine policy and make specific and tailored social value requirements in planning applications.

We have written the city-wide guidance for the Greater London Authority's (GLA) Good Growth by Design programme on Making London Child-Friendly; Safety in Public Spaces: Women, Girls and Gender Diverse People; and Developing a Night Time Strategy.




Making London Child Friendly, Good Growth by Design, Mayor of London/GLA, 2019









Selected Research & Policy Projects

Committed to the creation of a 24 hour city, our night time policies, designs and strategies are evidence-led, joyful and informed by local communities. Our aim is to help local economies thrive, make streets more welcoming after 6pm, diversify our high streets at night, promote safety and belonging at all hours, and celebrate London's 24 hour culture.

Publica have worked closely with the GLA on developing the strategy for London at night since 2019, as part of the Mayor's 24 Hour City Vision for London.

We have convened night surgeries across the whole city in partnership with boroughs and cities, most recently, in Bristol, and in London - in North Finchley, Vauxhall, Lewisham, and the Royal Borough of Kensington and Chelsea; and led night safety audits in London Heritage Quarter, Stratford, and Wood Green.

Developing a Night Time Strategy, 2021-ongoing

The GLA commissioned Publica to create the most ambitious night time guidance produced by any city in the world. It sets out the many benefits for local authorities, communities and businesses of creating diverse and inclusive night time plans, with step-by-step guides and inspiring case studies from across the globe on how this can be achieved.

Since then, we have worked with the GLA's 24 Hour team on the 24 Hour London support for boroughs, training Night Time Borough Champions and the ongoing development of the 24 Hour City Test.

Night Time Enterprise Zones Programme, 2024

The NTEZ programme aims to support councils, communities and businesses to make better use of their high streets around the clock and welcome people who previously avoided these areas. Publica documented and evaluated the results of the latest Night Time Enterprise Zones programme across Bromley town centre, Vauxhall and Woolwich in an extensive evaluation report.



Visions & Strategies

Publica's urban strategies reset whole districts. Our strategies establish robust principles for public realm regeneration projects, developments and masterplans across metropolitan, district and neighbourhood areas. We investigate and analyse the social, cultural, economic and spatial needs of a place to help guide successful growth. Our engaging, visually-led documents are advocacy tools and help our clients to set principles and build consensus around new projects.

We are currently working on strategies for some of London's biggest and most complex public spaces.

The Transformation of Marble Arch, 2019-ongoing

Publica has a vision for radical change at Marble Arch. We have been working with The Portman Estate for many years on a significant project to reposition the Inner Ring Road, re-connecting Oxford Street back to Hyde Park, as it once was, creating a public space the size of Trafalgar Square, and restoring the Arch's historic position as the entrance to the Park.

With many civic leaders engaged in a renewed focus on the future of Oxford Street, Marble Arch sits amongst a handful of strategic West End projects. Our vision is the latest piece of work in a long-standing collaboration between Publica and NRP that has brought major change to many of Central London's major spaces.

Northbank Public Realm Vision and Strategy, 2016

Our 2016 Vision and Strategy for the Northbank Business Improvement District outlined improvements to the public realm to enhance the area's remarkable existing assets and ensure its streets and public spaces became well-connected and welcoming. The strategy identified 40 projects across five geographical areas. One of the key projects identified by Publica was the removal of the traffic gyratory at Strand Aldwych. We subsequently worked with NRP on options testing to set the detailed brief for the public space. The project was adopted and delivered by Westminster City Council and opened in 2022.

Old Oak and Park Royal Development Corporation (OPDC) Planning Guidance, 2023


Publica was appointed by the OPDC to produce a suite of visualisations to support the development of two new Supplementary Planning Documents (SPDs) written by OPDC: Industrial Sites SPD, and Public Realm and Green Infrastructure SPD. The 34 detailed and locally specific drawings, depicting daytime and evening activity, helped develop and communicate emerging innovative planning to a wide audience, building engagement, support and consensus for strategies.

Engaging in a collaborative and iterative process with OPDC's planning team, Publica's illustrations supported the development and testing of emerging policy, evolving alongside the draft SPDs to inform the guidance at both wider and detailed scale. The policies have been awarded multiple awards and nominations including receiving the Plan-Making Award at the 2024 Planning Awards.




The Pennine Lancashire Linear Park, 2021

The Pennine Lancashire Linear Park is an exciting, pioneering vision and programme of change conceived for a 23-mile (37-kilometre) section of the Leeds & Liverpool Canal corridor.

Publica was commissioned by Arts Council England, Canal & River Trust, Creative Lancashire, Lancashire County Council and the Super Slow Way to carry out a cultural, economic and spatial study that would make the case for unlocking the immense potential of the area, while also serving as a call to action to reopen the debate around an ambitious and sustainable proposal to reshape the future of Pennine Lancashire. Our strategy helped achieve substantial Levelling Up funding.

Bond Street, 2015-2018

Publica was commissioned by Westminster City Council (WCC) to design Bond Street in 2015. Following an extensive survey, we set a vision and developed the unified concept design that was delivered and completed in October 2018. Publica maintained the role of design guardian throughout the project, ensuring that the concept design translated into a public realm of the highest standard. We worked alongside traffic and transport specialists NRP and with FM Conway-WSP for WCC, in partnership with the New West End Company (NWEC) and Transport for London (TfL).

Walthamstow Cultural Quarter, 2021-ongoing

The reopening of Walthamstow's former Granada Cinema as a theatre venue prompted a reimagining of the surrounding public realm and wider area as a stage for socialising, encounter, play, and celebration. Collaborating with the London Borough of Waltham Forest, Publica developed a masterplan for the area, identifying six key sites for design interventions that foster a welcoming sense of arrival in the area and improve legibility and wayfinding after dark.

Publica initially produced preliminary feasibility studies and a brief definition before developing concept proposals. Then, following in-depth consultation with the public and local stakeholders, we devised a detailed lighting and wayfinding framework alongside the council's technical delivery team.

The framework supports the creation of a new Cultural Quarter and established principles for creating diverse and characterful places in Walthamstow Central through theatrical lighting and thoughtful use of colour, interactive elements and pattern.

Works at Cairo Place are now complete, and ongoing improvements are being implemented at Hatherley Mews, Hoe Street and Rosebank Villas.

Publica's Community Interest Company (CIC) is campaigning for a change in how we design and plan inclusive cities.


The CIC exists because we recognise the urgent need to address inequality in our public realm. It offers expertise on gender and access inclusion, research, training and policy for local authorities, international city leaders, charities and community organisations.

The Campaign for Inclusive Cities launched at the London Real Estate Forum in 2022. It advocates for a public realm that is safer, more welcoming and accessible for women, girls and gender diverse people.

Our approach is focused on meaningful participation and collaboration with communities, to allow them to shape their own neighbourhoods. We know it is possible to create cities where streets feel like spaces for all to belong and where women, girls and gender diverse people can participate freely and fully in urban life.

Our aim is to upskill our sector. We have successfully tested a series of pilot projects nationally, and internationally to understand individual and community behaviours, drive city builders to learn and act together, and to influence systemic change. Publica CIC is running a major fundraising campaign to enable this work to flourish.

Selected CIC Projects

Gender Based Violence in Public Space: Developing an Evidence-Base and Action Plan with Three Cities, 2024–ongoing

Publica CIC is collaborating with CHANGE (City Hub and Network for Gender Equity) to drive global change on gender equity. The initiative explores how the design and management of the built environment can transform cities into safer, more usable and welcoming public environments for women, girls, gender diverse people and caregivers.

Drawing on a combination of research findings, the team has travelled across three cities: Louisville, Kentucky; Bogotá, Colombia; and Stockholm, Sweden to lead a series of workshops, training, neighbourhood walks and site visits, with local communities and the Mayor's offices of these cities.

Engagement with local policy-makers, city leaders, businesses, community organisations and residents is central to the development of our research, ensuring that the voices of those directly impacted inform every step of the programme.

Tailored recommendations for each city are being developed, providing actionable guidance for city leaders to implement gender-based violence prevention strategies in their own geographies.

Safety in Public Space: Women, Girls and Gender Diverse People, 2022-2024

Publica CIC designed a handbook for the GLA to support urban development practitioners to act towards gender inclusion in their public realm projects throughout the project lifecycle. It lays out key principles of safety and gender inclusion and a set of practical actions that can be taken by project teams.

We developed and tested these principles across ten live projects in the Capital, including the new London Museum development, Crystal Palace National Sports Centre, Kidbrooke Station Square and multiple developments on the Queen Elizabeth Olympic Park, with the support of the Mayor's Design Advocates. The practical actions are interspersed with lessons from these 10 projects and a set of global case studies, demonstrating how diverse engagement and thoughtful design processes can foster gender-inclusive public realm.

Right to the Streets: Trafford, 2023

Publica CIC produced and play-tested a series of games and activities to help empower project partners, designers, planners, policy makers and the wider community with in-depth knowledge to better understand public space through a gender lens. 
























Our Team
